# Kelvin Smith Library: Library Opportunity Grants 2002-2004

## Introduction

The Library Opportunity Fund is a grant program developed by Kelvin Smith Library and the Arts & Sciences Library Advisory Committee. The program awards funding to faculty to acquire interdisciplinary or specialized resources which will enhance the library's current collecting, as well as foster collaboration between faculty and librarians.

In the first round of funding in 2002-2003, the University Library, joined by the College of Arts and Sciences, invested more than \$75,000 in special resources for fifteen faculty members. These items included books, journals, manuals, newspapers, a play script and other resources to support faculty in English, Religion, Modern Languages, Music, History, Classics, Anthropology and Electrical Engineering and Computer Science, among others. The second round of funding in 2003-2004 produced twenty-three proposals from faculty in Arts and Sciences, Engineering, and Weatherhead for collections in various formats including several digitization projects. The Library was able to fund all proposals for a total of \$144,000, due to a large gift designated for library collections.

The Library Opportunity Fund addresses recommendations from the Case Faculty Senate Library Committee report *Faculty Priorities for University Libraries* regarding building and strengthening library collections. Improving acquisitions was also one of the principal requests in a recent LIBQUAL+ customer service survey of library patrons conducted by the University Library.

Winning faculty and librarians along with all who submitted proposals are honored at a luncheon, during which a selection of materials from each proposal is displayed or demonstrated.

**PURPOSE:**

The purpose of this request is to strengthen the library collections in the field of evolutionary biology.

Evolutionary Biology is a new interdisciplinary major staffed by faculty from the College of Arts and Sciences (Departments of Anthropology, Biology, Geology and Philosophy), the School of Medicine and the Cleveland Museum of Natural History. The interdisciplinary nature of the field and the wide range of topics (encompassing for example, paleontology, the philosophy of science, and comparative genomics) means that it is necessary to pay special attention to build a good base of library holdings that includes materials that might not be requested by any one department. For example, two new courses designed for the major (ANTH/BIOL/GEOL/PHIL 225 Evolution and ANTH/BIOL/GEOL/PHIL 394 Senior Seminar) will increase the faculty and student demand for a broad range of library materials with aspects of evolutionary biology.

Areas of need include:

1. Materials on human evolution:  
This is already reasonable due to the long history of faculty and student interest. It requires maintenance in order to keep up with new discoveries of fossils and new areas of investigation such as genetic history of human nature.
2. Materials on the evolution of other major taxa (e.g. bats, insects, birds) and major transitions (e.g. evolution of multicellular life, of vertebrates, of flight).
3. Materials on the general theory and mechanisms of evolution (e.g. the species concept, principles of classification, relative importance of natural selection relative to other forces of evolution).
4. Materials on the new topics of evolution and development and comparative genomic analyses.

BUDGET: \$4000 to purchase the books on the attached list.

**Purpose:**

To strengthen the literature holdings at CWRU in the area of medical innovation from an interdisciplinary perspective.

Modern medicine and medical technologies are inseparable, and are at the core of concerns about the structure and viability of healthcare in America. They have been the subject of study by various disciplines represented at CWRU including (but not limited to) history of medicine, biomedical ethics, medical anthropology, policy studies, medical economics, and sociology. Several new faculty and new research programs initiated by established faculty in these disciplines have found library holdings wanting at CWRU. The current proposal aims to redress this situation through 1) the acquisition of literature in certain targeted areas. These specific areas targeted for development include, but not limited to: Somatic therapies in psychiatry. Contraception and contraceptive devices. Reproduction: obstetrics and midwifery. Endoscopy and minimally invasive technologies.

The materials purchased will be divided between the Allen Medical Library and Kelvin Smith Library as appropriate.

Request: Funds to purchase backfiles of the journal Sight and Sound, 1981-1993.

Purpose: Sight and Sound is one of the most important film journals and is an important source for all studies of film and filmmaking, particularly those dealing with international film. It is a journal published by the British Film Institute and is not available online for these retroactive volumes. The title would be used by Dr. Ehrlich and her students in all film studies and in research. It would also be used by numerous other faculty and students in film courses taught in the English department, other Modern Languages courses, as well as Communications courses. It is one of the most important journals on this subject.

Funding required.

Volumes are not available in microfilm and must be purchased in hard copy and bound.  
Individual issues need to be purchased from the British Film Institute, as well as from several backfile vendors since BFI does not have all issues.

#### Introductory Resources for the Study of Chinese Music

Target audience: non-music majors studying Chinese culture and history. The ability to read music or familiarity with other technical music skills (such as western music theory or music analysis) will not be assumed.

Secondary audience: music majors taking world music classes or music appreciation classes with a world music component. Such classes are taught by a variety of music department faculty.

Materials acquired will include: audio CDs; books; videos (VHS or DVD); online resources (free or available via subscription) or journals. Materials will be housed in Kulas Music Library and Kelvin Smith Library. Primary subject matter covered will be traditional Chinese court, theater and religious music, but folk and popular genres will also be included.

Bibliography: an annotated bibliography of these materials will be prepared and maintained by Stephen Toombs and available at the Kulas Music Library website as a PDF file. This will serve as the primary guide for students and faculty using this collection.

Future of the project: in the spirit of the Library Opportunity Fund, funding for this request will serve as seed money to quickly enhance the collections in this area. In the future these collections will be maintained from the regular music library acquisitions funds. This project builds on a previously funded Library Opportunity Grant that developed introductory resources in the area of Japanese music. Many aspects of traditional Japanese music have links to traditional Chinese music and the development of the two areas will increase the usefulness of each individual area.

Submitted by Susie Hanson, Head of Special Collections, and Christopher Flint, Associate Professor of English.

Proposal Description:

A proposal to support the curriculum of Georgian studies and fill in gaps of major writers of the 18<sup>th</sup> and 19<sup>th</sup> century by acquiring authors for the research and classroom needs of the Departments of English, History, Art History, Women's Studies and Interdisciplinary Studies.

We request the acquisition of the following three titles to enrich and expand the specialized holdings of Special Collections and to augment the strengths of the collections in the University Library.

- Richardson, Samuel. *Clarissa, or the history of a young lady ...* London, 1748.

One of the most famous books in English literature as found in the Grolier Club's publication of *One hundred books famous in English Literature*. "Richardson is considered to be the father of the English novel. Dr. Samuel Johnson called the work "the first book in the world for the knowledge it displays of the human heart." (From the Randall House description of this work.)

- Richardson, Samuel. *Pamela, or virtue rewarded ...* London, 1741.

Called "...the first notable English novel of sentimental analysis... [it] was published to very considerable acclaim. The morality and realism of the work were particularly praised .." (From the Heritage Book Shop description)

- Austen, Jane. *Northanger Abbey and Persuasion*. London, 1818.

Austen's works are some of the most significant and popular titles in English literature today as proved by the many reprints of her books and recent film and TV productions. The addition of this work will enhance and add to our collection of sometimes-neglected women authors.

Purpose of acquiring these titles:

Richardson was a master printer as well as author and supervised production of his novels; his works are particularly useful for what they indicate about early modern textual production and print history. In fact, his novels, like Sterne's *Tristram Shandy*, which we already have, uniquely exploit typographical and textual effects that modern editions of the works fail to reproduce, but they do so in a radically different way than Sterne's and thus afford illuminating comparisons. Also, given that the English Department is bolstering its WHIT Program (Writing History and Theory), the new bibliography and sociology of texts will play a significant role in our offerings, for which Richardson as well as Sterne provide ideal models from which to work. These texts should be of interest to scholars not only of the printed word but of printed images as well.

The Austen volume would similarly be a vital addition since it provides a way of examining how women writers negotiated a print industry that tended to restrict their access to the print marketplace at the same time that it relied on them as authors in a burgeoning field of female authorship and a rapidly expanding female readership. That the Austen text bundles two of her works posthumously and provides an introduction that begins the process of canonizing an author who has come to dominate the history of the novel (and now film too) makes it an essential piece.

Each semester, Professor Flint, whose teaching and research interests include 18<sup>th</sup> century British literature and culture, holds

classes in Special Collections, introducing his students to original materials from the 18<sup>th</sup> and 19<sup>th</sup> centuries. These materials are used by the students for study and for class projects. These three titles would be of considerable consequence to the library, giving further distinction to our fine collections of British literature.

**PROPOSAL DESCRIPTION/PURPOSE:**

The Department's goal is to offer a comprehensive program in the study of religion, including major religion traditions as well as research intensive courses at the Senior, honors, and eventually masters level. This is the minimum needed to raise the Department to a level appropriate to a Private Research I University.

The current Library collection is minimally adequate for our general undergraduate courses, and inadequate for Senior Seminars, honors and Masters research. This lack is one obstacle to our starting up an Integrated Masters Studies program in Religion.

As a Department, we have surveyed our syllabi over the last four years and identified books we have required, recommend and/or placed in our course bibliographies. At the end of this process, we have identified shortages in three main areas.:

- I. Primary and secondary texts on the academic study of religion in general. For example we have no copies at all of some of the classics in the field such as J. van der Leeuw, *Phenomenology of Religion* and Paul Ricoeur, *Symbolism of Evil*. In addition, we have only one copy of many of the textbooks and primary classics in the field.
- II. Secondary texts on specific religious traditions that would support comparative religion courses or advanced research for senior Seminars, Honors Theses or the projected Masters (the greatest shortages are in Islam, less so in Hinduism, somewhat in Judaism and Christianity).
- III. Severe shortages on books dealing with religion and popular culture (for example cinema).

**BUDGET:** \$5000 for building up a collection in religion and popular culture

1. \$2000 for retrospective acquisition of classics and textbooks in the field.
2. \$3000 for filling in gaps in specific religious traditions in line with our syllabi.

**Purpose:**

To support research in the area of Cleveland Business History, The Mercantile Agency of New York's Reference Books is the major source of credit rating information about United States Companies. No Library in the Cleveland Area can provide this information. No area library owns the historical run of the title (information based on a search of WORLDCAT).

This reference provides a remarkably complete listing of business firms in all fields and of all sizes, by location, with important basic information on field of activity and creditworthiness. Using these volumes, a student can quickly obtain an overview of the firms in a given area. Economists and other students of regional economic development have, in recent years, been especially interested in the clustering of firms in particular industries in specific geographic areas.

Prof. Hammack has begun to use the Dun books to trace the evolution of the metal-working cluster in NE Ohio. His guess is that this region has been home to other clusters as well -- in parts of the chemical, rubber, and other industries, for example, and probably also in ready-made clothing. His hope is that if we can understand the rise and transformation and to some extent decline of such clusters over time, we will be in a better position to advise policy-makers as to how to foster successful economic development in the future.

Few sources allow undergraduates to get a better quick sense of such research -- or to make a quicker research contribution themselves -- than a good series of these volumes. Some of us have been working, with the encouragement of Dean Sandra Russ of the College of Arts and Sciences, to find ways to make the ENCYCLOPEDIA OF CLEVELAND HISTORY (on-line through the CWRU website, and the most comprehensive historical resource for any US metropolitan area).

The Dun books will help greatly in that enterprise, because they provide the most complete available listing of specific firms in each city.

Request and Purpose:

Digitization of "Programmschriften" in the Field of Classics

There was a tradition in German High Schools in the 18th and early 20th century to publish a dissertation of 20-100 pages, most often together with the headmaster's year end report. These pieces are known as "Programmschriften." Kelvin Smith Library and the Classics Department own a substantial number of Programmschriften which are out of copyright by now. Classics alone has around 150 of these. Many of these works contain extremely valuable information. In my work on Ovid, I regularly use at least four of these publications. These volumes have become very brittle by now and are mostly in cold storage where they are difficult to access.

We are therefore proposing to have many of these volumes scanned and then made accessible in PDF format on the World Wide Web. We have to take stock of all the publications before 1930 which total fewer than 80 pages. Then the faculty in the Classics Department have to select the ones they consider the most important. The documents have to be scanned by students in Kelvin Smith Library which has both the hardware and the software necessary for this task. Finally, the PDF files ought to be uploaded to a file server and made available to the scholarly community.

This project will give both the library and Classics at Case much needed visibility. It also has the potential of leading to a major grant application in collaboration with other universities. The University of Cincinnati, for instance, has very large holdings in this area. (252 words)

Library Note: This project would be consistent with one of the mission emphases of the library which is to make available unique materials of the collection on the web under the library's auspices and to preserve these materials in this way.

Budget

We are asking for the maximum award of \$ 10 000, to be used entirely for student help at a rate of \$ 10 per hour (if we can find capable work study students, the money can be made to go further). Experience teaches that it takes about two minutes to scan and save a page which may cover two sides of the original. Allowing time for uploading at the end maybe 3 minutes per scan and upload is more realistic. At \$ 10 per hour, we can pay for 1000 hours of student work. At 3 minutes per scan, a student can scan at least 20 pages per hour, 40 if the original is small enough, which in many cases it is. This would mean that a student can maybe scan one publication in two hours. An award of \$ 10 000 would therefore enable us to have 500 languishing library volumes digitized and thereby preserved as well as made accessible for every scholar from Los Angeles to Little Piddle, England.

Additional Information re Funding and Means:

Student Worker funding at \$10 an hour should be sufficient to accomplish this project given our estimates of the page numbers of each volume. I Sharlane Gubkin of Preservation sees this project as a feasible one. An alternative means to accomplish this project may consist of outsourcing the job in its entirety if the costs by available service vendors were equal to the student worker inhouse costs.

Case is the only OHIOLINK Library that has a full run of the title. The entire set is brittle. About 10 percent of the run is in a state of advanced decay: high acid paper has become brittle and begun to crumble, bindings and backs are broken. A microfilm copy, available from the Library of Congress, is necessary to permit Prof. Ledford and others to continue to use this valuable resource. Moreover, a film copy could form the basis for a process of digitization, assuming that the Library of Congress will agree. The Preservation Department of the Library and Prof. Ledford have expressed an interest in such a project.

As such it serves as the prototype of what was going to happen in business during the 20<sup>th</sup> century. Having a full picture of the financial reporting over the 100 years will give scholars a valuable "window" into how the process developed and changed over time.

#### Future

This project could be a cornerstone of a larger initiative that we hope to get underway – the creation of a web site on Cleveland Corporate History. It also ties in with the library's mission of digitizing, preserving and making unique materials available through the library's web site. At least one group of business and economic history scholars from other major institutions are using the Special Collection materials on other early Cleveland Industrial Companies.

As a faculty member at Case, I would like to continue advancing a line of research that addresses topics related to international business including foreign direct investment, cross-jurisdictional income shifting, and transfer pricing policies. These topics are interdisciplinary in nature combining perspectives from the fields of accounting, taxation, economics, finance, law, and cultural studies.

This proposal requests the acquisition of new resources not already featured in the KSLibrary's collections as well as materials to supplement existing holdings that are either incomplete or dated. Given the rapid pace of policy changes and developments concerning international business, library acquisitions are continually needed in this area to support research endeavors and to allow for the inclusion of current material in our department's curriculum. Examples include research-oriented and reference publications by the National Bureau of Economic Research, the Organization for Economic Cooperation and Development (OECD), The MIT Press, and The University of Chicago Press as well as more applied resources such as CCH, the Internal Revenue Code and regulations, and international accounting standards. The later items would ideally be accessible via electronic means, which would provide a continually updated source of information and provide students an opportunity to become proficient with the technologies used by potential employers.

Proposed Budget and Timeline: In order to support these endeavors, we respectfully request a total of \$5,000 with the following priority:

Immediate need for items related to:

- the development and implementation of International Accounting Standards (IAS) including reference books and related materials
- proposals in Congress to allow for U.S. corporations to repatriate foreign-source earnings at a reduced income tax rate
- the World Trade Organization's debate regarding the use of export subsidies including the U.S.'s foreign sales corporation (FSC) and the extraterritorial income exclusion

Ongoing need for acquisitions related to:

- foreign direct investment (FDI) by U.S. multinational enterprises
- global transfer pricing and income shifting practices
- international tax treaties
- export and import policies

PURPOSE OF THE REQUEST:

To purchase the 10 reel microfilm collection and guide – THE EMPIRE WRITES BACK—Part I: Indian views on Britain and Empire, 1810-1915, compiled from the British Library, London.

The collection will support several of Prof. Woollacott's courses: History 222 course - History of Modern England of which the impact at home of the British empire is an important part; History 223 Rise and Decline of the British Empire, which incorporates connections between the metropole and colonies; and History 321 Colonialism, Race, Sex and Gender, which includes a component of India as part of the British empire. THE EMPIRE WRITES BACK makes available memoirs which record the views and experiences of Indian visitors to Britain. Included are descriptions of university life and medical instruction; cultural and trade exhibitions and of English domestic life. The presence and observations of colonial subjects at the heart of the empire is currently a topic of significant scholarly concern and one on which Prof. Woollacott has published. London is compared with other European capitals and the British Empire is compared with rival European empires. The collection forms a complement to the writings about India and the Empire provided in the Colonial Discourse Series, owned by the library. The collection provides researchers with important primary source material relating to the development of the British Empire, and would be valuable for students' essay assignments.

BUDGET: \$1300 for the purchase of the microfilm collection
